# 2023/2024 SCHOOL YEAR RATES (Summer Camp Rates on Back)

## SCHOOL YEAR REGISTRATION - \$100 for 1<sup>st</sup> child in family, \$75 for each additional child

This annual fee is due at the initial time of enrollment and again each spring for the upcoming school year. The registration fee is not refundable once it has been paid. A full one-week notice, or payment of one week's additional fee, is required when a child withdraws from any program at the Child Development Center.

### ANNUAL CURRICULUM and/or SUPPLY FEE (Babies through K4) – FUEL SURCHARGE FEE (Elem)

These annual fees are due at the initial time of enrollment, and again every July for the upcoming school year. These fees are not refundable after the designated due date.

Baby Supply Fee: \$130 ------ K2, K3, K4 Curriculum/Supply Fee: \$150 ------ Elementary Fuel Surcharge Fee: \$100

## WEEKLY TUITION RATES - FULL TIME (12 MONTH PROGRAM)

This is a weekly fee for children enrolled in the full-time daycare program at the CDC. These children may attend anytime during regular operating hours (6am to 6pm). Daycare children must remain enrolled year-round (exceptions are made only as noted on the back of this sheet). There will be no reduction in weekly tuition fees for student absences, CDC or elementary school holidays, or CDC emergency closings.

Each additional child in the family enrolled in the full daycare/full week program will receive a \$10 family discount. Families who pay one month in advance by the first Monday in each month will receive a 5% total tuition discount.

# WEEKLY TUITION RATES PART-TIME KINDERGARTEN (8:00-2:30)

This is a weekly fee for children enrolled in **only** the part-time 8-2:30 program during our school year. Students may arrive no earlier than 7:45 in the mornings, and they must be picked up promptly at 2:30 in the carpool dismissal line. Students who are enrolled in this program are given the option of taking the summer months off, but they forfeit any vacation time earned during the school year if they do not remain enrolled year-round. The CDC observes the MCPSS cutoff date of September 1st for student placement in our K2, K3 & K4 classes.

K2: Partial Day Mon through Fri 8:00 - 2:30 **\$105 per week** (snacks, meals, beverages not included) K3 & K4: Partial Day Mon through Fri 8:00 - 2:30 \$ 95 per week (snacks, meals, beverages not included) An early arrival (before 7:45 a.m.) is offered for an additional \$10 per week. Each additional child in the family enrolled in the partial day/partial week program will receive a \$5 family discount. Families who pay one month in advance by the first Monday in each month will receive a 5% total discount.

### <u>WEEKLY TUITION RATES – BEFORE and/or AFTER CARE (SCHOOL YEAR PROGRAM)</u>

This fee is for children enrolled in our Before and/or After School Care program. Transportation is available to and from Faith Academy, Allentown, E.R. Dickson, Mertz, Old Shell Road and Council Elementary Schools. Transportation is also available for PreK4 students from some schools. Service is not provided for Faith Academy early dismissals or for holidays that do not coincide with Mobile County Public Schools. There will be no reduction in weekly fees for absences during holiday periods. Children enrolled in this program are given the option of taking the summer months off, but they forfeit any vacation time earned during the school year if they do not remain enrolled year-round.

# SUMMER CAMP (May 30-Aug .4) REGISTRATION FEE - \$50 per child

Summer Camp is available to children who have completed K4 up through 5th grade who attend ONLY during the summer session. Summer Camp is not available to students who are in a Pre-K 3 program at public schools during the school year. The summer session registration fee is due at the time of enrollment and is not refundable.

## SUMMER ACTIVITY FEE – Due By May 16, 2023

This fee is for ALL K4 through 5<sup>th</sup> grade students who attend during the summer months. The fee helps to offset the costs of the weekly field trips for the older classes, and summer activities for the younger classes. This fee is due annually and it is not refundable. There is no refund or reduction in fees for field trips that have to be cancelled, or for children who do not attend on field trip days or who are not permitted to attend a trip due to behavior issues. ## SUMMER WEEKLY RATES - FULL TIME

This is a weekly fee for children enrolled in the full Monday through Friday summer daycare program. Snacks, meals and beverages are not included.

Elem Completed 1st through 5th Grades: \$125 per week (field trips included) Completed K4/K5: \$118 per week Each additional child in the family enrolled in the full daycare/full week program will receive a \$10 family discount. Families who pay one month in advance by the first Monday in each month will receive a 5% total discount.

## SUMMER WEEKLY RATES – PARTIAL WEEK

This is a fee for daycare or Summer Camp children who are enrolled in only the partial week summer session. We offer a choice of attendance days for either M/W/F or for T/Th for K3 up through 1st grade. Summer Camp students in 2nd through 5th grades may choose 2 or 3 flexible days to attend during the week. Snacks, meals and beverages are not included.

Each additional child in the family enrolled in the partial day/partial week program will receive a \$5 family discount.

Families who pay one month in advance by the first Monday in each month will receive a 5% total discount.

### MISCELLANEOUS FEES

**NSF/DECLINE PYMT FEE:** Tuition is due every Friday for the upcoming week. A grace period extends through Tuesday. Payments may be paid using cash, check, money order, credit or debit card (Visa, Master Card or Discover). They may also be paid online through the Procare website. Any account with a remaining balance due on Wednesday morning will be automatically charged to the credit card on file, or drafted from the checking account on file. If an auto draft payment is declined due to non-sufficient funds, or due to an issue with the credit card (expired, locked, no credit available, closed account, etc...), a \$30 service fee will be charged.

AFTER HOURS PICKUP FEE: The CDC closes at 6:00 each day. Late pickup fees are charged by the minute after 6 p.m.

ELEM NO CALL FEE: A \$10 fee is charged if parents do not notify the CDC that their child will not be on the afternoon bus

VACATIONS/HOLIDAYS: There is no reduction in fee for absences, holidays or temporary closings due to loss of power or bad weather conditions. After attending the CDC for twelve consecutive months, each child enrolled will be allowed two weeks of vacation time, per calendar year, without paying. Vacations must be taken on a Monday through Friday basis. Vacation requests must be submitted at least one full week in advance, and accounts must be current by Wednesday, prior to the week that is requested. Students enrolled for ONLY the Summer Camp program will not qualify for vacation credit.

LEAVES OF ABSENCE: Children enrolled in the full daycare program, including children of school teachers and other 9month employees, are required to remain enrolled year-round, unless they meet one of the following qualifications:

OR

\*Non-Custodial Parent Summer Visitation – Maximum 4 weeks annually (court documentation required) <u>OR</u>

\*Maternity Leave following sibling's birth when mother is not working – Maximum 6 weeks

\*Summer Exemption (MCPSS dates) for CDC kindergarten (8-2:00) students or Elementary students (Summer Break)

No fee will be charged to hold the child's space during these periods, but all annual vacation must be forfeited if a Leave of Absence is used. Elementary students taking the summer exemption must pay for every week of the MCPSS school year in order to qualify. No combination of the Leaves of Absence listed above may be used during the same calendar year.
